## About Boating Safely valid through 30 June 2021

NASBLA has extended its approval of this course through June 30, 2021. Flotillas may continue to issue NASBLA certificates for ABS courses offered during this time. This can be a chance for flotillas to use any ABS books that they have in stock. If any flotillas have any ABS books they do not anticipate using, they should email <u>sean@auxgoldengate.org</u> and we can help manage inventory.

## Maxim Award nominations from division due 31 March 2021

February 28 was the deadline for flotillas to nominate instructors (for both PE and MT service) to the divisions. The deadline for each division to nominate one instructor to district is March 31.

The COMO Daniel Maxim Award for Excellence in Education was established last year at the national level to recognize the top instructor in the entire Auxiliary. Nominations begin at the flotilla level and each flotilla may make one nomination to division. Each division then forwards just one of its flotillas' nominations to district. As a district we get to forward one of our divisions' nominations to PACAREA, and PACREA sends one district nomination (from Districts 11N, 11S, 13, 14, and 17) to national.
