Div 10, Joseph has been promoting both the ADV, Dock Walker and MS Training programs


## **DSO Activities**

This was approved by National I Prevention and presented for the first time by both D8, and D11N on June10.

ADSO Michael Mitchell also compiled the CFV videos ( & Tiny Coastie) prepared by CIV CFVS Sector Manny Ramirez as a refresher class for both CG and Aux qualified CFV members.

## Marine Environmental Pollution Event: American Challenger Marin County



Current Situational Report from Sector SV on the American Challenger

Greetings Mr. Sumner,

Below is a summary of the current status of the M/V AMERICAN CHALLENGER:

The M/V AMERICAN CHALLENGER ran aground on 05 Mar 2021 in Bodega Bay, California, with an undetermined amount of fuel and oil on board. This vessel is a former commercial fishing vessel, 90 feet in length, and was homeported in Seattle, Washington.

Since activating the Oil Spill Liability Trust Fund on 05 Mar 2021, a unified command (UC) was established to respond to and mitigate the environmental threat. A detailed assessment on board the vessel has been completed and all fuel tanks were assessed; many tanks were found to be tidally influenced with sea water due to flooding from through-hull penetrations and oily water was identified and recovered. The remaining environmental threat remains isolated to the machinery space. Efforts to manually clean the machinery space have proven extremely difficult or high risk, and contractors are unable to effectively mitigate the full threat. The vessel remains hard aground listing to starboard with no waterside or shore side access; the only contractor access is via helicopter.

The Unified Command is continuing to assess how to properly and effectively mitigate the pollution threat from the M/V AMERICAN CHALLENGER.

## Oil Spill and Sheen Reporting



While on Patrol, AUXFAC Margarita came across an oil spill/sheen that was 30 feet long and roughly 2 feet across. All oil spills and sheens are to be reported to your OIA the National Response Center (800 424 8802) and/or the State Warning Center (800 645 7911) when on Sole State Waters.. Not all oil spills are recoverable, such as the oil spill observed above. We assumed that a recreational boater pumped out his bilge containing crankcase oil based on the color and consistency.

## **Sea Partners Activity**

With Phase 3 in place, Aux Members can now participate or organize shore line clean up activities and Dock Walker Surveys. You will need to request for an Assignment to Duty for this mission from one member who would be the POC and a mass gathering form for risk assessment. The POC would need to verify that each participating member has a high risk form on file.

#### Commercial Fishing Vessel and Uninspected Passenger Vessel Examinations.

National fisheries have opened up the Commercial Salmon Season to start May 1 south of Pigeon Point. On June 16, the remaining portions of both California and Oregon will open for commercial salmon fishing. The recreational fishing for Salmon and ground fish will open on June 26. This will increase our activity for both UPV and CFV exams.

# Marine Safety Training for 2021

On May 13, the Commercial Fishing Vessel Examiners Beta version was attended by 14 participants.

On May 24, the Shoreline Cleanup Assessment Technique Class was attended by 13 participants.

On June 10, the National Uninspected Passenger Vessel Examiners class was attended by 11 Participants.

On June 15 & 16, Sector San Francisco and D11NR will be putting on the HAZWOPER OPERATIONS refresher class. This class is required for all members participating in ADV and SCAT activities.
