With Phase 3 in place, Aux members can now participate in Sea Partners missions, Dock Walker Surveys, Shoreline Cleanup Exercises. and get signed off on their MEES PQS, section 5.

DSO & ADSO Activities

National Strategic Goal UPV Training to meet the UPV Training PQS requirements was initiated. BC PVP Wil Sumner was assigned this task and have edited 3 of 9 power points. D 08 David Gruber and D Western Rivers Robert Heinz have been assigned to edit sections 4-9.

DSO MS met on July 10 with the new Aux UPV coordinator in District 13 to discuss strategies on how to implement UPV exams in District 13, Oregon and Sector Columbia River. They plan on modeling their program based on the UPV program in District 11 NR. The new UPV coordinator is Chuck Mc Carty, formerly from Div 5, D11NR.

ADSO Michael Mitchell has been at TAHOE participating in Industry Days for Charter Boats and getting both Bill Stoltz and Bruce Martin set up as UPV Examiners

Sea Partners Activity

With Phase 3 in place, Aux Members can now participate or organize shore line clean up activities and Dock Walker Surveys. You will need to request for an Assignment to Duty for this mission from one member who would be the POC and a mass gathering form for risk assessment. The POC would need to verify that each participating member has a high risk form on file.

Commercial Fishing Vessel and Uninspected Passenger Vessel Examinations.

National fisheries have opened up the Commercial Salmon Season to start May 1 south of Pigeon Point. On June 16, the remaining portions of both California and Oregon will open for commercial salmon fishing. The recreational fishing for Salmon and ground fisheries opened on June 26. We have conducted over 12 CFV exams in the past 3 weeks and over 6 UPV exams.

Marine Safety Training for 2021

On June 10, District DSO MS Wil Sumner and Michael Mitchell hosted the new National Uninspected Passenger Vessel Orientation class. This was attended by 11 participants.
