**Boat America Approved for California**

Boat America is now officially approved in California for obtaining a California Boater Card. Thanks to our national E directorate staff for getting that done. Please let us know if any of your Boat America students run into any issues obtaining California Boater Cards.

**Required Instructor Workshop**

We have 134 instructors who completed the required IT workshop on time and who therefore remain in active status. We have 49 instructors who are in REWK status for not having had a workshop submitted into AuxData by the deadline (although six of those are now showing a workshop completion in AuxData).

The IT workshop is located at the E-Directorate website "[What's New!](#)" page (in the Member Zone). Members who individually view the IT workshop in their entirety must submit a [Workshop Attestation Form](#) to their FSO-IS for entry into AUXDATA II.

Instructors completing the workshop should work with their FSO-MT and FSO-IS to get the workshop submitted into AuxData and their instructor status manually changed by DIRAUX from REWK back into active.
