A link to the tutorials is at the end of this report. Remember to change your PV activity from New to Requested or nothing will happen.

Flotilla 05-07 reported that they setup a new partner with is a boat rental business. BZ to them for getting a new partner that will see a lot of boaters and paddle craft users. Rental businesses are a great place to get RBS material into the hands of the casual or new boater. It is also great place to do vessel inspections too.
