Status of the Instructor Corps

As of 0800 on 03AUG, we have **163 active (certified) instructors** and **34 instructors in REWK status**, due to the lack of a 2021 required workshop being recorded in AuxData. This means 83% of our instructors are in active status, which is the same as the national average.

We continue to work with the instructors, SO-PEs, FSO-PEs, FSO-ISs, and SO-ISs to get our instructors to complete the workshop and to get those workshops recorded in AuxData. In reaching out to instructors, we have had some decide to archive their instructor qualification.

Instructor Development Course

At NACON, the national E directorate staff was going to train DSO-PEs on how to offer the Instructor Development Course 2020 (IDC 2020). NACON has now been indefinitely postponed. We are working with national E directorate staff to see if they can offer a virtual train-the-trainer on IDC 2020.
