Subj: December 14 2021 D11NR DSO-PE Report

Status of the Instructor Corps

We have **168 certified instructors** (-6 from last month) and **24 instructors in REWK status** (no change from last month). This means 87.5% of our active (non-REYR) instructors are in certified status (-0.4% from last month). In addition to the active corps, we currently have 243 instructors in REYR status.

However, **only 75 of our active instructors have sufficient instructor hours for 2021** recorded in AuxData to avoid REYR classification at the end of the year. This means that over half of our currently active instructor corps is on pace to enter REYR status at the end of the year. In order to avoid REYR status, each instructor needs a total of two "points" of instructor time, with each lead instructor hour counting as one point and each non-lead instructor hour counting as half of a point. Remember, both MT and PE instructor hours count (if properly entered into AuxData).
